A 14-year-old from Sioux Falls, South Dakota, met his first girlfriend through a mutual friend in June of 2008. The United States Supreme Court has consistently held that children different than adults must be treated accordingly within the justice system. However, the Court has yet to apply this precedent to youth placed on sex offender registries. Instead majority of states still place youth on registries despite its detrimental impact. This article discusses the history and unconstitutionality of placing youth on sex offender registries and urges jurisdictions to reexamine their youth registration practices.

he longitudinal analysis demonstrated that for sex offenders released from prison both prior to and after implementation of SORN, there are clearly two distinguishable groups of sex offenders in relation to patterns of recidivism. More than three-quarters of sex offenders were identified as at low risk of recidivism, with low rates of repeat criminal offenses. By contrast, the high-risk group of offenders was not only more likely to commit future criminal offenses, including sex offenses, but they were also more likely to commit significantly more offenses and to do so quickly following release.

The passage of these three new laws in New Jersey and in many other states, in addition to that which is yet to come, reflects a substantial sea change in legislative emphasis, and perhaps in judicial emphasis as well, toward greater protection of vulnerable women and children from sexual assault which necessarily results in some diminution of the civil liberties of sex offenders, raising difficult constitutional and moral questions concerning the balance to be struck between these two antithetical values.
